

# Applying for an Alfresco Dining Licence

## General Information

### When is a licence needed?

When you would like your customers to be able to dine in a public space, namely footpaths, in open air or under a tent, marquee or other temporary shelter.

### Why do I need to have public liability insurance?

So that the business is covered in the event of a liability claim from an incident in the licensed area, as Council does not indemnify private business operations.

### Does this affect my alcohol licence?

When alcohol licences are issued there is a licensed premises definition plan that is date stamped and referred to in the licence. This shows the area that is covered by the alcohol licence.

If you hold an alcohol licence (an On Licence) you will also need to update the area to which the alcohol licence relates. Once the alfresco licence has been granted, you can then submit a variation application, including a new licensed premises definition plan, to the Southland District Licensing Committee. For more information about this process please contact Council's licensing inspectors.

Consumption of alcohol must not commence outdoors unless the area is covered by the alcohol licence and the alfresco dining licence is granted.

### How long are licenses issued for?

Three years, after which they must be renewed. A change of ownership does not affect the licence period, it will still expire on the date in the original licence.

### What are general criteria for a licence?

Some key criteria are:

- a minimum unobstructed clearance of 1.5m of footpath being available for pedestrians at all times
- umbrellas are confined to the area and do not encroach onto the pedestrian way, and are at a height that is safe for pedestrians
- alfresco dining and associated street furniture are confined to the area of footpath directly outside the premises
