The following standard is applicable for both chemical and mechanical control of roadside vegetation. This includes properties on the No Spray Register.

General: Vegetation and weed control shall include but not be limited to the following areas:

- traffic islands and medians
- gravel and grass shoulders
- water tables/channels, roadside drains
- kerb and channel, footpaths
- around sign posts, marker posts, guard rails and sight rails
- around culvert, sump inlets and outlets.

The above areas shall be kept in a weed free-state at all times.

Vegetation and weeds shall be controlled along the full length of the boundary or the area identified by the No Spray markers.

Particular care shall be taken to achieve total eradication of weeds in and around water tables, roadside drains, kerb and channel and culvert inlets/outlets so as to maintain a clear drainage path for stormwater runoff.

Road Reserve Areas:

The following is a list of noxious plants/weeds that need to be eradicated:

- Broom
- Gorse
- Nodding Thistle
- Ragwort
- Barberry
- Blackberry.

No Spray Zone Signs

It is the applicant's responsibility to ensure the placement of 'No Spray' signs approximately 1 m from the road edge or on their property fence (note: the fence line and signs must be clearly visible from the road).

If new signs are required please indicate on application form and these will be sent out with approval.

Spacing between signs in urban areas shall be no greater than 50 m and in rural areas 100 m.
